Fund Commentary

The Emit Capital Climate Finance Equity Fund fell –1.10% for October net of fees & costs. The Benchmark MSCI ACWI gained +2.78%

The Fund's best performers were Nvidia (+62bps), Delta Electronics (+41bps) and Tetra Tech (+32 bps). Activity and positioning was principally geared towards the US election in early November, with the market in generall appearing to favor the "Trump" trade throughout October.

Regionally, North American holdings added +55bps, Asia-Pacific +10bps, whilst all other regions were negative performers with Japan giving up the most at -54bps.

Energy Transformation was the best performing theme on the back of the Al power demand strategy, followed by Energy Efficiency holdings with Transport & Infrastructure the negative for the month. The Fund maintained strong ESG ratings, with top holdings such as First Solar (FSLR) and Acciona SA (ANAe) receiving high scores for environmental and social metrics.

All eyes were focused on the US and the Presidential election. In particular, the differing economic policy announcements from the candidates. Trump emphasizes tax cuts, deregulation, and policies aimed at bolstering U.S. manufacturing, energy independence, and trade protectionism. His economic platform historically has aimed at stimulating economic growth through reduced taxes on corporations and high-income individuals, potentially believing this spurs investment. His stance on climate regulation has typically been deregulative, with limited federal intervention on carbon reduction. Harris's economic approach was expected to prioritize equity, labor rights, and significant investments in green infrastructure and technology to address climate change.

With the majority of the global economy emerging from a high inflation period, key will be the impact of the new President's policies on prices in the US. A return to inflationary outcomes for voters will be anti to their voting intentions.






